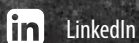

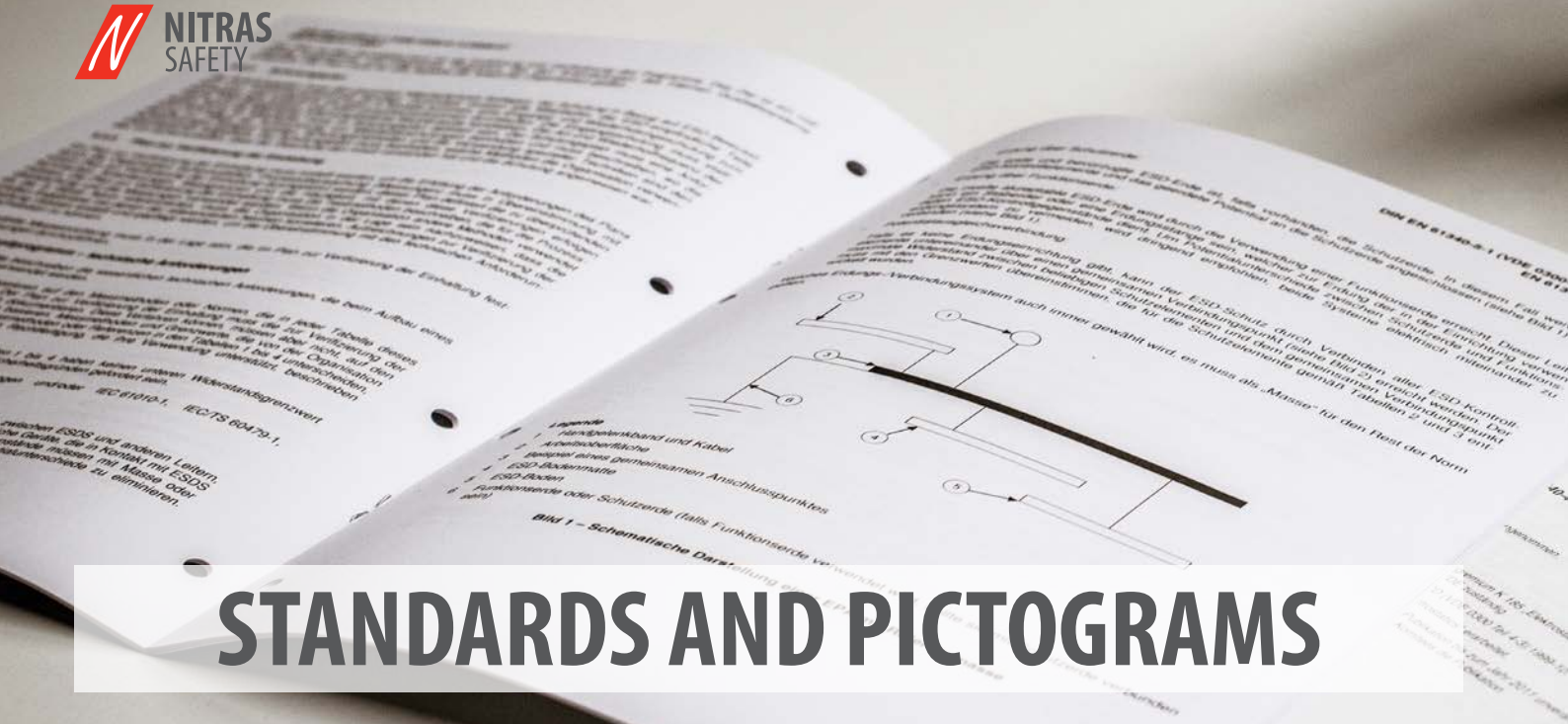

## Medical face masks

This European standard defines the general requirements regarding the transition of infectious germs during surgical operations in operating rooms and other medical areas. Sources of infections can be, for example, noses and mouths of members of the operation team. The main focus for the use of medical face masks is the protection of the patient against infectious germs and in certain situations also the protection of the person wearing the masks against splashes of contaminated liquids and living particles. Medical face masks can also be worn by patients and other persons in order to prevent the spread of infections, especially in infectious and pandemic areas.
